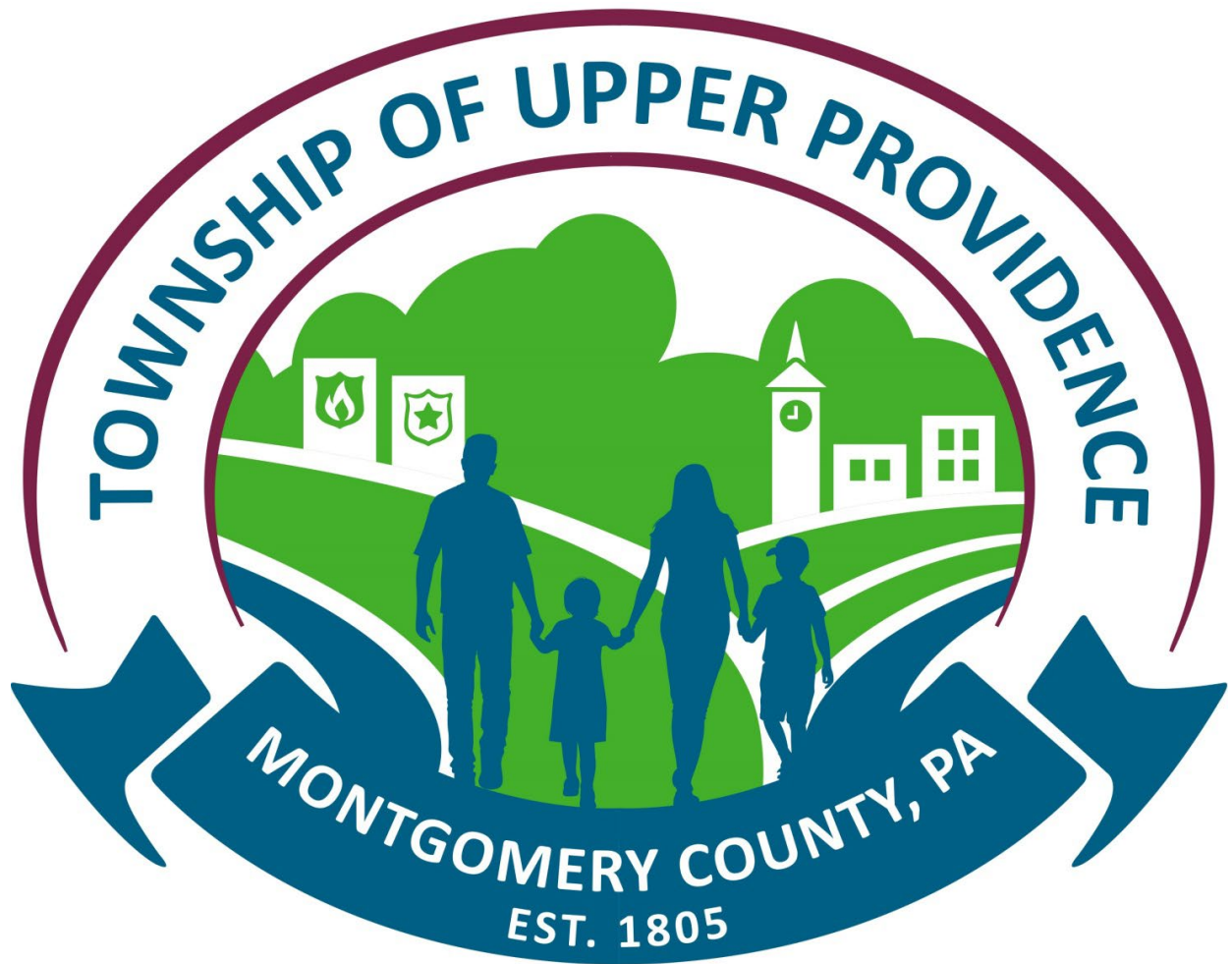

SUB-DIVISION/LAND-DEVELOPMENT (cont.)

Plan Review Escrow: In addition to the Non-Refundable Application Fees described herein, each Applicant, Owner, Sub-Divider, or Developer seeking approval of any Zoning change (map or text), amendment, curative amendment, sub-division ordinance amendment, or any plan for sub-division or land development shall place into escrow with the Township, at the time of application, an amount as outlined below to cover all costs of Engineering reviews and/or inspections, Professional planning review (not to include the Montgomery County Planning Commission application fee), specialized Legal Services, and other professional services used by the Township in connection with the application. From this escrow, the Township shall pay invoices of these professionals, as they become due. When the escrow amount is determined to have become insufficient during the processing of an application, less than 50% of the escrow balance, the Township may require additional funds from the applicant before the application is processed any further. Any amount remaining in the Plan Review Escrow Account after the Applicant's Final Plan has been recorded and the associated Development Escrow Agreement has been executed, and all invoices related to that application have been paid, will be refunded to the Applicant.
