

What is Sustainability?

Sustainability is “the ability to be maintained at a certain rate or level; avoidance of the depletion of natural resources in order to maintain an ecological balance.”¹ Simply put it means meeting the needs of the current generation without compromising the ability of future generations to meet their own needs. It encompasses more than just environmental issues.² Sustainability includes topics such as social equity, natural resources and economic development spanning over systems economic, environmental, societal and personal.



Environmental Sustainability: Making sure that the natural resources we use can be replenished while keeping all environmental systems in balance.

Economic Sustainability: Making sure that residents have access to the financial and other resources they require to meet their needs and allow them to access sources of livelihood.

Social Sustainability: Giving residents access to basic resources to keep their families healthy and secure while maintaining universal human rights.³

As we continue to grow in social and economic regions, environmental concerns increase. Issues such as pollution, climate change, efficient and affordable energy continue to arise. In order to guarantee resources are available for our future generations, actions must be taken.

What is Sustainable PA?



The Sustainable Pennsylvania Community Certification, a project of the Pennsylvania Municipal League and Sustainable Pittsburgh, is a voluntary performance recognition program designed to help municipalities achieve sustainability goals, which in turn will allow them to save money, conserve resources, and encourage innovation.

Governance and Community Engagement

Municipal Operations:

1A: Professional staff are employed or retained, in the areas of budgeting and finance.

Land Use and Transportation

Mobility:

21A: Trails for walking and bicycling are being developed or maintained.

Summary: Trails are a very important part of Upper Providence Township. Both the Schuylkill River Trail and the Perkiomen Trail run through the municipality helping connect our residents to Valley Forge and Philadelphia. Our most recent trail completion is a small trail connecting Route 29 and the Municipal Campus to the Schuylkill River Trail via Lock 60.

21B: Alternate transportation are accommodated and promoted.

Summary: Upper Providence Township was recently awarded the “PA WalkWorks” grant which focuses on Complete Streets policies and an active transportation plan that will run parallel with the Municipality’s Comprehensive Plan update and promote alternative methods of transportation such as biking.

21E: Police are trained on the rights and responsibilities of bicyclists and state law on passing bicycles.

Summary: The Upper Providence Township Police Bike Patrol participate in Bike safety training once a year, and the Township Police Officers are well versed in rights of and state laws for bicyclists.

21F: Traffic calming techniques, “complete streets” projects, access management and congestion management programs have been evaluated and are being implemented.

Summary: In 2019 Upper Providence received the “PA WalkWorks” grant in order to help maintain the Complete Streets project. The Township is implementing current adopted policies to ensure traffic congestion is managed efficiently.

22A: Professional staff are employed or retained to manage the land use program.

Summary: Upper Providence Township has appointed Geoffrey Grace to the position of Township Zoning Officer and Director of Planning and Zoning. The Township follows its 2010 Comprehensive Land Use Plan and evaluates each application based on each adopted zoning ordinance.

22B: Comprehensive land use/development plan is current, addresses impacts to neighboring communities, and incorporates sustainability principles.

Summary: The Municipal Comprehensive Plan goes in depth to discuss the impacts the plan has on neighboring municipalities and how any impacts, if any, will be handled between the neighboring municipalities and Upper Providence Township. The plan also incorporates sustainability principles through its goals to improve traffic issues, preserve historic places and open space.

22F: A Transfer Development Rights (TDR) program is in place to incentivize development where infrastructure currently exists and to protect important green space.

Summary: Upper Providence strives to preserve and protect lands with unique and valuable environmental features and reduce the negative impacts of suburbanization. To help do this, there are specific zoning ordinances in place to guide future development to work in tandem with the Township's goals.

22G: Developers are required to submit a comprehensive and detailed fiscal impact analysis including long-term fiscal impacts such as road repairs, school infrastructure needs and other public services with their development applications.

22H: Land use and development decisions are assessed to ensure they do not have negative fiscal, stormwater, traffic, infrastructure, or service demands, or quality of life impacts on neighboring municipalities.

Summary: Chapter 182 of the Township Code along with the Upper Providence Township Planning Commission help to regulate land use within the municipality. Specific criteria are laid out for each zoning district to help ensure that developments and proposed land uses do not negatively impact fiscal, traffic, infrastructure and environmental conditions in Upper Providence and neighboring municipalities.

Green Space:


